FFA members Stotz, Holsworth, and Stikelstad and FFA Advisor Todd reported to the board about what they did and learned on their trip to National Convention and also a stop at a large dairy and pig operation in Iowa. Their trip was a great learning experience and they advised all FFA members to go to National Convention if they get the chance. At this time they left the meeting.

In his Superintendent report Mr. Serna reported that he is finalizing the E-Rate process. The Veteran's Day Program was held today and there was a very nice turn out. Parent/Teacher Conferences were held. He is starting to work on the 2019-20 class schedule. The Foundation Pheasant Phest was well attended. He has put out bids for a bus.

Jr. High and 7th and 8th grade Girls Basketball was discussed. The JV and Varsity teams will be very short on participants and some of the girls from 7th and 8th grades will have to be moved up to fill in on JV and Varsity teams. This will be left up to the coaching staff's discretion.

Senior privilege guidelines were reviewed. It was decided that Senior privileges will start March 1, 2019. It was also determined that a grade point average of 79% or better must be maintained to participate. The Senior Trip agreement was also reviewed.

Title I review went well. At this time it was discussed to change how the Title I Program is conducted.

Motion by Stotz and seconded by Schlechter to change the Title I Program to be Elementary wide instead of targeted assistance for the 2019-20 school year. This will bring the Title I teacher into the classroom and more students will be helped. All voted aye. Motion carried.

Mr. Serna passed out a policy for Food Service Procurement to board members to review and it will be addressed at the December meeting.

Motion by Oxner and seconded by Stotz to enter Executive Session at 6:50 pm for SDCL1-25-2 (1) Personnel and SDCL 1-25-2 (2) Student. All voted aye. Motion carried.

At this time Nelson, Beitelspacher, and Oxner left the meeting.
